PART 1 A.1	Footnote 3	Samples were not collected within the first 60 minutes of the discharge at Outfall 001.	Due to safety concerns with accumulation of water at the terminal, it is not always possible to delay the initiation of a discharge until such time that a sample can be collected within the permit timeframe. Since stormwater is stored prior to discharge, Global believes that the discharges are relatively homogeneous and that identified samples are representative of the discharge.
