Global Companies LLC (Global) and Chelsea Sandwich LLC are transmitting the attached annual certification for the Stormwater Pollution Prevention Plan (SWPPP) associated with the above-referenced National Pollution Discharge Elimination System (NPDES) permit and Massachusetts Surface Water Discharge permit (MassDEP permit).

Note that NPDES and MassDEP Permit No. MA0003280 was recently renewed (effective December 1, 2022) and includes requirements that will result in an update to the SWPPP. This update of the SWPPP is in progress and will be submitted to EPA and MassDEP no later than March 1, 2023. In the future, SWPPP certifications will be submitted by January 15th covering the previous year per the effective permit. This certification applies to the SWPPP that was in effect as of the date of the certification.
